

RESOLUTION No. 208480

Adopted on JUL 26 1973

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Pursuant to authority conferred by and in accordance with the provisions of Section 86.04 of the San Diego Municipal Code, a PARKING TIME LIMIT OF TWO HOURS, between the hours of 8:00 a.m. and 6:00 p.m., Sundays and certain holidays excepted, be and the same is hereby established on the following streets in said City:

Westerly side of LA JOLLA SHORES DRIVE, between El Paseo Grande and Scripps' Vaughan Museum entrance; and northerly side of EL PASEO GRANDE, between La Jolla Shores Drive and west entrance to University of California's parking lot.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same are hereby authorized to be made on said street, and that the regulations hereinabove imposed shall become effective upon the installation of such signs.
