A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE STREET VACATION ACT OF 1941, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE A STREET RESERVATION IN LOTS 36, 37, 38 AND 41 THROUGH 46, COLLWOOD UNIT NO. 1 AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

is hereby directed to cause notices of the passage of this resolution to be posted in the manner and form required by law and to cause a notice similar in substance to be published in said newspaper in the manner required by law.
