

RESOLUTION No. 208503


Adopted on JUL 31 1973

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that Grant of Easement of SAN DIEGO GAS & ELECTRIC COMPANY, a corporation, executed in favor of The City of San Diego, bearing date of June 22, 1973, conveying to said City an easement and right-of-way for public street and utility purposes and incidentals thereto in portions of Pueblo Lots 1103 and 1176 of the Pueblo Lands of San Diego, as more particularly described in said Grant of Easement, be and the same is hereby approved, and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named VIA LAS CUMBRES.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing Grant of Easement for record in the office of the Recorder of San Diego County.
