
RESOLUTION CONSIDERING THE PROTESTS, ORDERING THE DISTRICT FORMED, CONFIRMING THE ASSESSMENT AND ORDERING THE PROPOSED MAINTENANCE, IN THE MATTER OF THE TIERRASANTA OPEN SPACE MAINTENANCE DISTRICT NO. 1.
