WHEREAS, until recently the multidisciplinary approach to problems of transportation was not taught in undergraduate or even in graduate schools; and

WHEREAS, an intensive six-week program in urban transportation for training administrators concerned with various aspects of transportation has been developed by the Transportation Research Institute of Carnegie-Mellon University; and

WHEREAS, the Urban Mass Transportation Administration, U. S. Department of Transportation, has evaluated the Carnegie-Mellon Professional Program in Urban Transportation and finds it appropriate for fellowship support; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the City Manager of The City of San Diego is authorized to submit an application for financial assistance to the Department of Transportation for the purpose of obtaining a fellowship for the City's Planning Director or his representative to attend the Carnegie-Mellon University Professional Program in Urban Transportation, in the form of application on file in the office of the City Clerk as Document

No. 744435.

BE IT FURTHER RESOLVED, that if the fellowship is approved the City Manager is authorized to accept the grant and execute the required contracts, and make whatever additional applications or arrangements that may be required, ~~all in the form of contracts and applications on file in the office of the City Clerk as Document NO.~~
