BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$128,101.20 by R.E. Hazard Contracting Co., a corporation, for IMPROVEMENT OF SCOTT STREET BETWEEN ADDISON STREET AND NORTH HARBOR DRIVE IN THE VICINITY OF LOMA PORTAL, including Alternate "A", in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 738775.
2. That the expenditure of \$143,400.00 is hereby authorized out of Gas Tax Fund (Fund No. 220) of the City of San Diego solely and exclusively for the purpose of providing funds for IMPROVEMENT OF SCOTT STREET BETWEEN ADDISON STREET AND NORTH HARBOR DRIVE IN THE VICINITY OF LOMA PORTAL, including Alternate "A", in the City of San Diego, and related costs.
