

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$34,545.00 by DBX, INC., dba Perry Electric, a corporation, for CONSTRUCTION OF SAFETY LIGHTING SYSTEMS ON WEST MISSION BAY DRIVE BETWEEN INGRAHAM STREET AND MISSION BOULEVARD AND INGRAHAM STREET BETWEEN WEST MISSION BAY DRIVE AND NORTHERLY END OF VACATION ISLE in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 743837.
2. That the expenditure of \$43,000.00 is hereby authorized out of Bond Fund (Fund No. 725) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF SAFETY LIGHTING SYSTEMS ON WEST MISSION BAY DRIVE BETWEEN INGRAHAM STREET AND MISSION BOULEVARD AND INGRAHAM STREET BETWEEN WEST MISSION BAY DRIVE AND NORTHERLY END OF VACATION ISLE in the City of San Diego, and related costs.
