1. That the bid of \$23,857.00 by Winter W. Rouse, an Individual, dba W.W. Rouse, Mechanical, for CASA DEL PRADO CENTRAL PLANT IMPROVEMENTS in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 743860.
2. That the expenditure of \$16,125.00 is hereby authorized out of Casa del Prado Bond Fund (Fund No. 729) and that the expenditure of \$8,875.00 is hereby authorized out of San Diego Planetarium Bond Fund (Fund No. 920) of the City of San Diego solely and exclusively for the purpose of providing funds for CASA DEL PRADO CENTRAL PLANT IMPROVEMENTS in the City of San Diego, and related costs.
