


RESOLUTION No. 208551

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the offer of San Diego Pipeline Company is hereby accepted, and the City Manager is hereby authorized to execute a contract to RELOCATE A 10" PETROLEUM PIPELINE UNDER MIRAMAR ROAD for a total cost not to exceed \$40,000.00;
2. That the expenditure of \$40,000.00 is hereby authorized out of the Gas Tax Fund (220) of the City of San Diego solely and exclusively for the purpose of providing funds to RELOCATE A 10" PETROLEUM PIPELINE UNDER MIRAMAR ROAD in the City of San Diego, and related costs.
