

RESOLUTION NO. 208558 AUG 7 1973

WHEREAS, The City of San Diego is the owner of a certain sewer easement affecting a portion of Lot 5, Valle Granado, as granted by deed recorded November 13, 1967 as Recorder's File/Page No. 177847; and

WHEREAS, the owner of said Lot 5, Valle Granado has requested an exchange of easements to allow better utilization of the land; and

WHEREAS, the easement to be acquired will serve the same use and purpose as the easement to be quitclaimed by the City; and

WHEREAS, the value of the property rights to be exchanged are approximately equal, neither exceeding \$500.00 in value in the opinion of the State Division of Highways; and

WHEREAS, this project is exempt from an environmental assessment by reason of its being a disposition of a City-owned real property interest with a fair market value of less than \$20,000; and

WHEREAS, it is in the public interest that said exchange be made, and the City Manager, pursuant to Section 22.0902.2 of the San Diego Municipal Code, has recommended it; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of, and as the act and deed of, The City of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk

as Document No. 74440, quitclaiming to the STATE OF CALIFORNIA a portion of Lot 5, Valle Granado, an existing easement for sewer purposes, as more particularly described in said form of quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk of said City be, and he is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
