

RESOLUTION NO. 208569 AUG 7 1973


WHEREAS, this Council did on July 27, 1972, adopt Resolution No. 206149, authorizing the City Manager to execute for and on behalf of said City, agreements with THE ATCHISON, TOPEKA AND SANTA FE RAILWAY COMPANY for the engineering design and construction of automatic crossing gates at Cedar Street, 231.2 (2-267.2) and Beech Street, 231.3 (2-267.25), said agreements having been filed in the office of the City Clerk under Document No. 740768; and

WHEREAS, subsequent to said resolution's adoption, the railway company desired to alter the preamble and paragraph 1. of both agreements, said alterations being minor in nature; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, two agreements for engineering design and construction of automatic crossing gates at Cedar Street and Beech Street, under the terms and conditions set forth in the form of agreements on file in the office of the City Clerk under Document Nos. 744454 and 744455, respectively.
