BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, a grant agreement with the URBAN MASS TRANSPORTATION ADMINISTRATION (UMTA) in the amount of \$3,047,130 for the purchase of thirty-three (33) 25-passenger buses; twenty-five (25) 53-passenger buses; and thirty-eight (38) new radios, and numerous supporting equipment, to be used in conjunction with City transit services, under the terms and conditions set forth in the form of grant agreement on file in the office of the City Clerk as Document No. 744464.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer the sum of \$27,690 from Public Transportation Reserve Fund 2571 to Transit System Purchase 58 Buses Fund 2574, to cover one percent City sales tax requirement.
