

RESOLUTION NO. 208572 AUG 7 1973

WHEREAS, City and Valley Crest Landscaping, Inc. entered into a contract, on file in the office of the City Clerk as Document No. 743588, for the improvement of the Mission Valley Multi-Sports Field adjacent to San Diego Stadium; and

WHEREAS, the local baseball organization for the Mission Valley Babe Ruth League has requested that the baseball Pony League ballfield be expanded to accommodate play by the Babe Ruth League; and

WHEREAS, the Mission Valley Babe Ruth League has offered to donate \$982.00 for the expansion of the baseball field; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Change Order No. 1, dated July 19, 1973, heretofore filed with the City Clerk of said City as Document No. 744169, issued in connection with the contract between The City of San Diego and Valley Crest Landscaping, Inc. for the improvement of the Mission Valley Multi-Sports Field, said contract having been filed as Document No. 743588, in the office of the City Clerk, be, and the same is hereby approved; and the changes therein set forth, amounting to an increase in the contract price of \$1,964.00 be and the same are hereby approved.

2. That The City of San Diego hereby accepts the generous contribution of \$982.00 from the Mission Valley Babe Ruth League

for the sole and exclusive purpose of providing funds for the
aforementioned improvements contained in Change Order No. 1.

3. That this Council does hereby commend the Mission
Valley Babe Ruth League for this act of civic generosity and
does hereby publicly express on behalf of the citizens of San
Diego a debt of gratitude to the Mission Valley Babe Ruth
League.
