

RESOLUTION NO. 208603 AUG 14 1973

APPROVING MAP OF BALBOA PLAZA UNIT NO. 1
SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by E. F. COOK, Registered Civil Engineer, and entitled "BALBOA PLAZA UNIT NO. 1 Being a subdivision of a portion of Pueblo Lot 1210 in the Pueblo Lands of San Diego, according to Map thereof made by James Pascoe in 1870, a copy of said Map having been filed in the office of the County Recorder November 14, 1921, as Miscellaneous Map No. 36, together with all of Lots 1535, 1536, 1537 and portions of Lots 1538 and 1539 of Clairemont Unit No. 8, according to Map thereof No. 2889, filed in the office of the County Recorder of San Diego County on July 23, 1952, together with Alley vacated to public use, all being in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.



Council has rejected Parcel A, marked "Reserved for Future Street" shown on this map within this subdivision, all as above stated.
