

RESOLUTION NO. 208604 AUG 14 1973

RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO, CALIFORNIA, RESCINDING RESOLU-  
TION NO. 208429, ADOPTED JULY 17, 1973,  
AND DIRECTING THE CITY CLERK TO GIVE NOTICE  
INVITING SEALED BIDS FOR THE FIRST PHASE  
OF CONSTRUCTION OF IMPROVEMENTS.

(Mission Boulevard South Assessment District)

WHEREAS, the Council has by Resolution No. 208252, adopted  
June 26, 1973, declared its intention to create the Mission  
Boulevard South Assessment District; and

WHEREAS, the Regional Coastal Commission did on July 20,  
1973, by unanimous vote (9 to 0), approve said project; and

WHEREAS, an appeal filed with the State Coastal Commission  
has held up issuance of the permit necessary to proceed with  
said project; and

WHEREAS, the State Coastal Commission will not act upon  
said appeal before September 5, 1973; and

WHEREAS, August 28, 1973, is the date presently designated  
in Resolution No. 208429 for the award of construction contracts  
and the sale of bonds; and

WHEREAS, such awards cannot be made until a date after  
September 5, 1973; NOW, THEREFORE

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

1. That Resolution No. 208429, adopted July 17, 1973,  
directing the City Clerk to give notice inviting sealed bids

for the purchase of improvement bonds and the construction of improvements be and it is hereby rescinded.

2. That sealed bids for the construction of that portion of the improvements shown and described in Construction Contract No. 1 plans, 21 sheets, numbered 15036-1-D to 15036-21-D, inclusive, and Special Specifications No. 2783-1, as contained in the Report shall be received by the Purchasing Agent up to 11:00 a.m., September 12, 1973. The City Clerk is directed to give notice, in the usual form, inviting such bids, such notice to be given in the manner provided by law.
