

RESOLUTION NO. 208612

ADOPTED ON AUG 16 1973

BE IT RESOLVED by the Council of The City of San Diego as follows:


1. That all bids theretofore received on June 28, 1973, pursuant to publication of notice calling for bids on CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT THE INTERSECTIONS OF 19TH STREET AND CORONADO AVENUE; GENESEE AVENUE AND APPLETON STREET/LEHRER DRIVE; LA JOLLA VILLAGE DRIVE, VILLA LA JOLLA DRIVE AND VETERAN'S ADMINISTRATION DRIVE; 30TH STREET AND EL CAJON BOULEVARD; AND THE MODIFICATION OF AN EXISTING TRAFFIC SIGNAL SYSTEM AT 54TH STREET AND TROJAN AVENUE are hereby rejected; and
2. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT THE INTERSECTIONS OF GENESEE AVENUE AND APPLETON STREET/LEHRER DRIVE AND LA JOLLA VILLAGE DRIVE, VILLA LA JOLLA DRIVE AND VETERAN'S ADMINISTRATION DRIVE, San Diego, California on AUG 10 1973, and bearing official Document No. 744501 be, and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Council has ascertained the current or prevailing rate of per diem wages paid by private employers in the City for each craft or type of workman or mechanic needed to execute the contract, and does hereby declare that the wage scale included in said specifications is the said current or prevailing rate for the various crafts therein mentioned.

BE IT FURTHER RESOLVED, that the Purchasing Agent of The City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
