Adopted on AUG 16 1973

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to modify the San Diego Regional Summer Youth Program upon receipt of the Neighborhood Youth Corps (NYC) Department of Labor funds as follows:

1. Increase the number of hours per participant from 20 to 26 hours per week for 9 weeks for a total of approximately 4,000 youth participants; and

2. Reallocate funds previously authorized for the San Diego Regional Summer Youth Program in City Council Resolution No. 208259 as indicated below:

a. Reallocate PEP funds for use as follows:

(1) City of San Diego PEP -	\$ 94,200
(2) County of San Diego PEP -	\$251,760

b. Reallocate General Revenue Sharing funds

and interest thereon as follows:

(1) Accelerated acquisition of Centre City properties	\$175,000
(2) Funding certain critical jobs in various City Departments	\$122,360
