Robert E. Mc Daniel	POLICE DEPARTMENT	\$360	Sgt. Mc Daniel observed that an established procedure of verification of correction for equipment traffic warnings which were not forwarded for prosecution was taking a great deal of time (about 5-1/2 hours per day). This is only needed on cases which <u>are</u> forwarded for prosecution. The others did not serve any useful purpose, and he suggested discontinuing a large part of the procedure. This saves an estimated \$3,622 of clerical time.
John E. Polloreana	PARK & RECREATION Park Division	\$160	Mr. Polloreana is a Groundsman-Gardener in the Park Division. Some time ago he designed several devices to be used for mass plantings of flowers and shrubs. These have been used in four park areas for some time. They have been found to save considerable time and improve results in regard to straight rows. The first-year savings have amounted to \$1,581.
