

RESOLUTION NO. 208634 AUG 21 1973

WHEREAS, the Council has in Resolution No. 206666 directed the City Manager to prepare plans, drawings and specifications for the acquisition, improvement and maintenance of an area to be known as Park Northeast Open Space District, described in said resolution; and

WHEREAS, said proposed open space district encompasses approximately 100 acres, 180 ownership parcels and 304 separate assessor's parcels; and

WHEREAS, preliminary title reports, independent fee appraisals and private engineering work will be required to comply with said Council direction; and


WHEREAS, the Council by Resolution No. 206866 created a revolving fund of \$100,000 within the Environmental Growth Fund 2505 for payment of incidental costs connected with open space projects;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the expenditure of \$30,000 is hereby authorized out of the revolving fund created by Resolution No. 206866, said expenditure to be solely and exclusively for the purpose of providing funds for one independent fee appraisal, preliminary title reports and private engineering work on the property to be acquired for the Park Northeast Open Space District.
