BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of CHARLES H. DOBSON, JR. and MARIE L. DOBSON, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of January 8, 1973, conveying to said City a portion of the North Half of Lot 3 in Block 3 of Homedale, according to Map thereof No. 1358, filed in the Office of the Recorder of San Diego County, August 23, 1911, as more particularly described in said deed, be, and the same is hereby approved and the Easterly 24.00 feet of the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named 47TH STREET.

That the expenditure of \$8,200 is hereby authorized from Gas Tax Funds solely and exclusively for the purpose of providing funds to cover all acquisition costs necessary to acquire the aforesaid real property.

That the City Clerk be and he is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deed to the Property Director of The City of San Diego for recordation and further handling.
