

RESOLUTION NO. 208644 AUG 21 1973

RESOLUTION APPROVING PLANS AND PROFILES SHOWING THE CONTEMPLATED CHANGES AND MODIFICATIONS IN THE WORK DESCRIBED IN RESOLUTION OF INTENTION NO. 208360, FOR THE IMPROVEMENT OF THE ALLEY IN BLOCK 26, LOMA ALTA NO. 2 AND SUSTAINING THE MAJORITY PROTESTS PERTAINING TO THE ALLEYS IN BLOCKS F AND G, RIVIERA VILLAS, AND ESTABLISHMENT OF THE GRADE ON ALLEY, BLOCK F, RIVIERA VILLAS.

WHEREAS, this City Council did on July 10, 1973, adopt Resolution of Intention No. 208360 and declare its intention to order the construction of certain improvements as more fully described therein and on the plans, profiles and drawings therein referred to, and did provide for the cost of certain work to be assessed against the district described in said Resolution of Intention; and

WHEREAS, the public interest, convenience and necessity require that certain changes and modifications be made in the proposed work to be done in said Resolution of Intention and that said Resolution of Intention be amended to delete the alleys in Blocks F and G, Riviera Villas, and the provision to establish the grade on Alley, Block F, Riviera Villas; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


1. Written protest or objection against the proposed improvement has been made by the owners of more than one-half of the area of the land included within the assessment district or of the area

of property to be assessed. Each and all oral and written protests and objections, if any, made or filed in the matter are hereby sustained.

2. The proposed improvement within the limits mentioned in Resolution of Intention No. 208360, pertaining to the alleys in Blocks F and G, Riviera Villas, and establishment of the grade on alley, Block F, Riviera Villas, is hereby determined that the public convenience and necessity do not presently require the proposed improvement.

3. That the plans, drawings, typical cross-sections, profiles and specifications for the improvement of the ALLEYS IN BLOCKS F AND G, RIVIERA VILLAS, AND IN BLOCK 26, LOMA ALTA NO. 2, AND ESTABLISH THE GRADE ON ALLEY, BLOCK F, RIVIERA VILLAS, heretofore filed in the office of the City Clerk as Document No. 743946 and approved by Resolution No. 208359, be and the same is hereby amended to conform with the modified specifications filed in the office of the City Clerk as Document No. 744701, and the same are hereby approved and adopted as the official drawings, typical cross-sections, profiles and specifications for said work and improvement.
