- 1. Each and all oral and written protests and objections, if any, made or filed in the matter are hereby overruled and denied.

The proposed improvement within the limits mentioned in Resolution of Intention No. 208360, as amended by Resolution No. 208644, pertaining to the alley in Block 26, Loma Alta No. 2 only, is hereby determined to be feasible and that the lands to be assessed therefor will be able to carry the burden of such proposed
