LIVINGSTON and VIRGINIA CASPE LIVINGSTON, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of December 5, 1972, conveying to said City an easement and right of way for street purposes, a right of way for earth excavation or embankment, slope or slopes, and a right of way for the construction, operation and maintenance of a storm drain or drains, over, under, upon, along and across a portion of Lot 1, H.L. Barrows Subdivision of a portion of Section 9, Township 15 South, Range 3 West, S.B.B.M., according to Map thereof No. 704 filed in the office of the County Recorder of San Diego County, as more particularly described in said deed, be, and the same is hereby approved, and the land therein conveyed as Parcel 6 is hereby dedicated as and for a public street and the same is hereby named MIRAMAR ROAD.

That the City Clerk be and he is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deed to the Property Director of The City of San Diego for recordation and further handling.
