
Adopted on AUG 23 1973

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute for and on behalf of said City an agreement with WILLIAM LAW & ASSOCIATES for engineering design of traffic signal and safety lighting systems at the intersections of Fulton Street at Linda Vista Road and Hancock Street at Sports Arena Boulevard, in the City of San Diego, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 744673.

BE IT FURTHER RESOLVED, that the expenditure of \$2,400 and \$2,300 is hereby authorized out of Gas Tax Fund 220 and Capital Outlay Fund 245, respectively, of The City of San Diego, solely and exclusively for the purpose of providing funds for said engineering design of said traffic signal and safety lighting systems and related costs.
