BE IT FURTHER RESOLVED, that the expenditure of \$3,500 is hereby authorized out of Gas Tax Fund 220 of The City of San Diego, solely and exclusively for the purpose of providing funds for said engineering design of said traffic signal and safety lighting systems and related costs.
