

RESOLUTION NO. 208680 AUG 23 1973

WHEREAS, Section 21101 of the Vehicle Code of the State of California provides that local authorities may adopt rules and regulations by resolution on the matter of temporarily closing a portion of any street for celebrations, parades, local special events and other purposes when such closing is necessary for the safety and protection of persons who would use that portion of the street during the temporary closing; and

WHEREAS, it is the opinion of this City Council that it is necessary in connection with the Fiesta Del Verano and in connection with the celebration of Mexican Independence to temporarily close SAN DIEGO AVENUE from Twiggs Street to Harney Street; NOW, THEREFORE,

BE IT RESOLVED, that that portion of SAN DIEGO AVENUE from Twiggs Street to Harney Street be temporarily closed from:

1. 5 p.m. August 24 to 8 a.m. August 25;  
8 a.m. August 25 to 5 p.m. August 25 (easterly half only);  
5 p.m. August 25 to 6 a.m. August 26, 1973


for the "Fiesta Del Verano" and

2. 5 p.m. September 14 to 8 a.m. September 15;  
8 a.m. September 15 to 5 p.m. September 15 (easterly half only);  
5 p.m. September 15 to 6 a.m. September 16, 1973

for the celebration of Mexican Independence.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to post any and all necessary signs to effectuate said temporary closings.
