WHEREAS, a joint report by the Office of the City Manager and the Planning Department of The City of San Diego entitled "Tia Juana River Valley Land Use and Flood Control Alternatives" was published and submitted to Council in May, 1973; and

WHEREAS, Council in conference on July 13, 1973, received and considered this report; and

WHEREAS, Council at a noticed public hearing on July 24, 1973, received public testimony; and

WHEREAS, Council requested additional response by the City Manager to questions raised at this hearing; and

WHEREAS, at a continued public hearing on August 23, 1973, Council considered the City Manager's report of August 20; and

WHEREAS, additional testimony was provided at this continued hearing; NOW, THEREFORE,

BE IT RESOLVED by the Council of The City of San Diego, as follows:

That the land use and flood control proposal known as Alternative III-A, as presented in the report of May, 1973, is approved in concept.

BE IT FURTHER RESOLVED, that the City Manager and the Planning Director are instructed to present to Council for its consideration the necessary legislative steps to effect this alternative.
