

RESOLUTION NO. 208689 AUG 28 1973

VACATION OF LIBERTY STREET BETWEEN OLLIE  
STREET AND STATE HIGHWAY ROUTE 8.

BE IT RESOLVED, by the Council of The City of San Diego, California, that LIBERTY STREET between Ollie Street and State Highway Route 8, as more particularly referred to in Resolution of Intention No. 208491 is unnecessary for present or prospective public street purposes.

BE IT FURTHER RESOLVED, that the public interest, convenience and necessity of said City requires the reservation of a certain public easement, as more particularly described below and referred to in Resolution of Intention No. 208491.

BE IT FURTHER RESOLVED, that LIBERTY STREET between Ollie Street and State Highway Route 8, as more particularly shown on Map No. 12869-B on file in the office of the City Clerk as Document No. 744338, which said map is attached hereto and made a part hereof, be, and the same is hereby vacated.

BE IT FURTHER RESOLVED, that The City of San Diego reserves and excepts from the foregoing vacation the permanent easement as more particularly described hereinafter.

Reserving and excepting to The City of San Diego the right, easement and privilege of placing, constructing, repairing, replacing, maintaining, using and operating drainage facilities and all necessary and proper fixtures and equipment for use in connection therewith, through, over, under, upon, along and across the hereinafter described easement, together with the right of ingress thereto

and egress therefrom, together with the right to maintain the said easement free and clear of any excavation or fills, the erection or construction of any building or other structures, the planting of any tree or trees thereon, or the drilling or digging of any well or wells thereon, together with the right to otherwise protect from all hazards the operation and use of any right hereby reserved. Upon written permission of the City, the owners of the underlying fee may utilize the above described parcel of land for structures, the planting or growing of trees or the installation of privately owned pipelines.

The easement reserved herein is in, under, over, upon, along and across that portion of LIBERTY STREET vacated by this document, and is more particularly shown on Map No. 12869-B on file in the office of the City Clerk as Document No. 744338.

BE IT FURTHER RESOLVED, that the City Clerk shall cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.

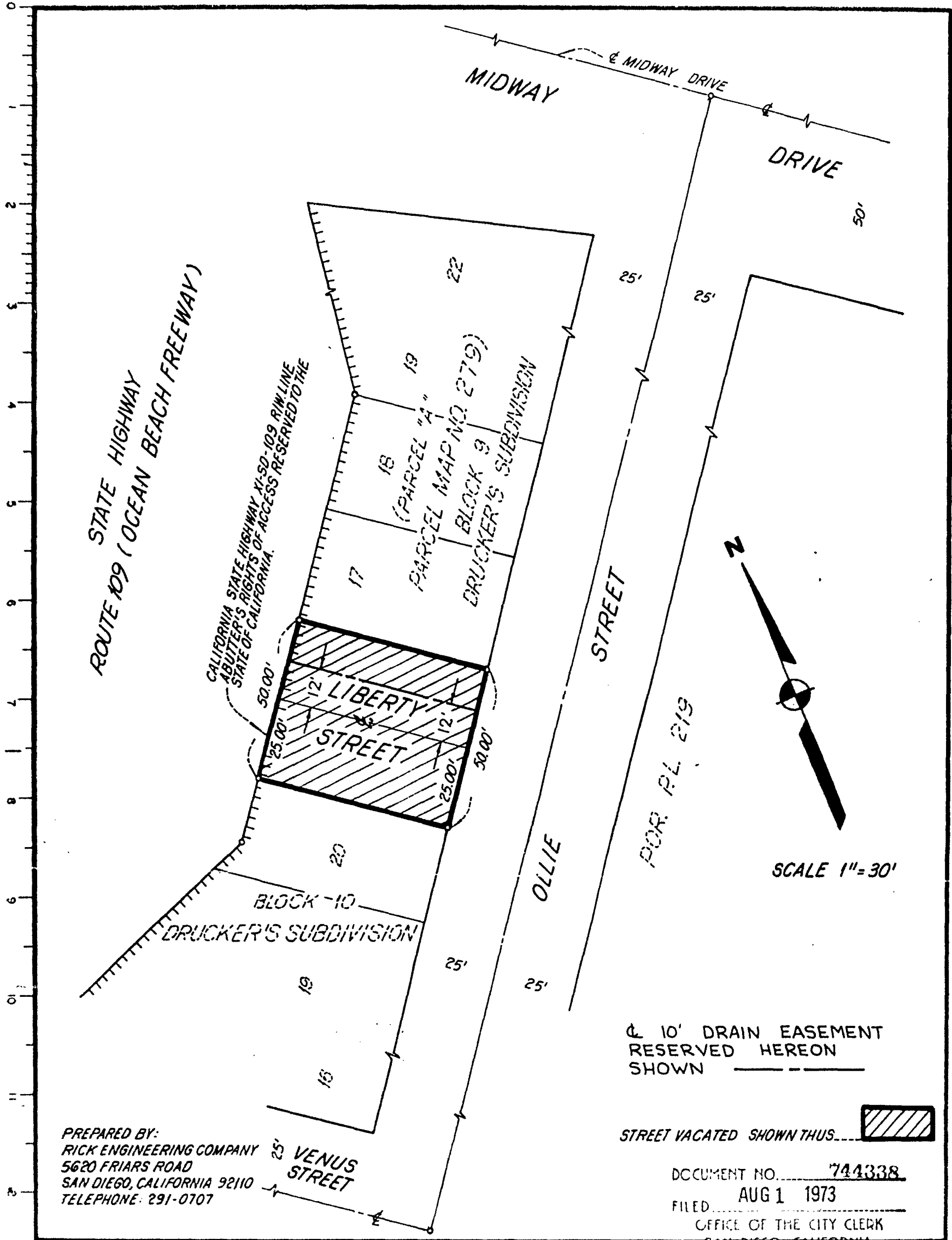
