


RESOLUTION No. 208690

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$68,863.00 by DBX, Inc. dba Perry Electric, a corporation, for CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT CLAIREMONT MESA BOULEVARD AND RUFFIN ROAD, AND CLAIREMONT MESA BOULEVARD AND GENESEE AVENUE in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 743812.
2. That the expenditure of \$80,000.00 is hereby authorized out of Gas Tax Fund (Fund No. 220) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT CLAIREMONT MESA BOULEVARD AND RUFFIN ROAD AND CLAIREMONT MESA BOULEVARD AND GENESEE AVENUE in the City of San Diego, and related costs.
