


RESOLUTION No. 208703

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute for and on behalf of said City a Lease Agreement with WOSK INVESTMENT COMPANY, leasing a portion of Lot A consisting of the second floor of the building located at 659 Kettner Boulevard, and that portion of Lot C for appurtenant parking, of Block 21 of New San Diego, for a five-year term with an option to extend for two additional one-year periods, at a rental of \$1,000 per month plus property taxes assessed against the parking area, for the purpose of maintaining offices of the San Diego Police Department, under the terms and conditions set forth in the form of Lease Agreement on file in the office of the City Clerk as Document No. 744723.
