APPROVING MAP OF DIVISION HIGHLANDS UNIT NO.2 SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by GARY L. McCABE, Registered Civil Engineer, and entitled "DIVISION Being a subdivision of a portion of the HIGHLANDS UNIT NO. 2 Northwest Quarter of Quarter Section Lot 79 in Rancho De La Nacion, according to Map thereof No. 166, filed in the office of the County Recorder of San Diego County, May 11, 1869 and that portion of Lot 29 of Encanto, together with a portion of Encanto Street, now known as 61st Street, according to Map thereof No. 749, filed in the office of the County Recorder of San Diego County, May 6, 1893, together with a portion of Division Street as dedicated to public use, all being in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following streets and portion of street: Daisy Avenue, Daisy Place, and a portion of Division Street, for public purposes, and said streets and portion of street are hereby declared to be public streets and portion of a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Division Street, adjacent and contiguous to Lots 45, 46 and 47, all as shown and granted on said map.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portion of public street are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
