BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute for and on behalf of said City an agreement with the UNIVERSITY OF CALIFORNIA, a corporation, for a program of workshops on audiences and participation in leisure arts in order to expand the impact of cultural programs on the minority community, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 744749.

BE IT FURTHER RESOLVED, that the City Auditor be and he is hereby authorized and directed to transfer from the Unallocated Reserve to the Park and Recreation Department, within General Fund 100, a sum not to exceed \$8,000; and the expenditure of said sum is hereby authorized from General Fund 100 solely and exclusively to provide funds for the services as stated above.
