BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to expend \$1,540 from the General Purpose Revolving Fund (Fund 534), solely and exclusively for the above purpose, City to be reimbursed by Peace Officer's Standards and Training, State of California, for all expenses incurred.
