BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO, regarding the Linda Vista Shopping Center Redevelopment Project and providing for \$30,000 for professional and administrative services in connection with the redevelopment of the Linda Vista Shopping Center, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 744755.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer the sum of \$30,000 from the Environmental Quality Improvements, CIP 34-007(4) to Redevelopment Agency - Linda Vista Shopping Center Redevelopment Fund 985, to be used in carrying out the terms of the agreement with the Redevelopment Agency for the redevelopment of the Linda Vista Shopping Center Redevelopment Project.
