That the acceptance by the City Manager of that deed of SWEETWATER UNION HIGH SCHOOL DISTRICT OF SAN DIEGO COUNTY, CALIFORNIA, executed in favor of The City of San Diego, bearing date of July 12, 1973, conveying to said City an easement and right of way for public street and highway purposes upon, over, and across a portion of Lots 7 and 8 and that tract of land named "George" of Tibbett's Tract, according to amended map thereof being licensed survey Map No. 24 filed in the Office of the County Recorder of San Diego County, November 25, 1892, as more particularly described in said deed, be, and the same is hereby approved, and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named HOLLISTER STREET.

That the City Clerk of said City is hereby authorized and directed to file the foregoing said deed for record in the office of the County Recorder of San Diego County.
