present or prospective public street purposes.

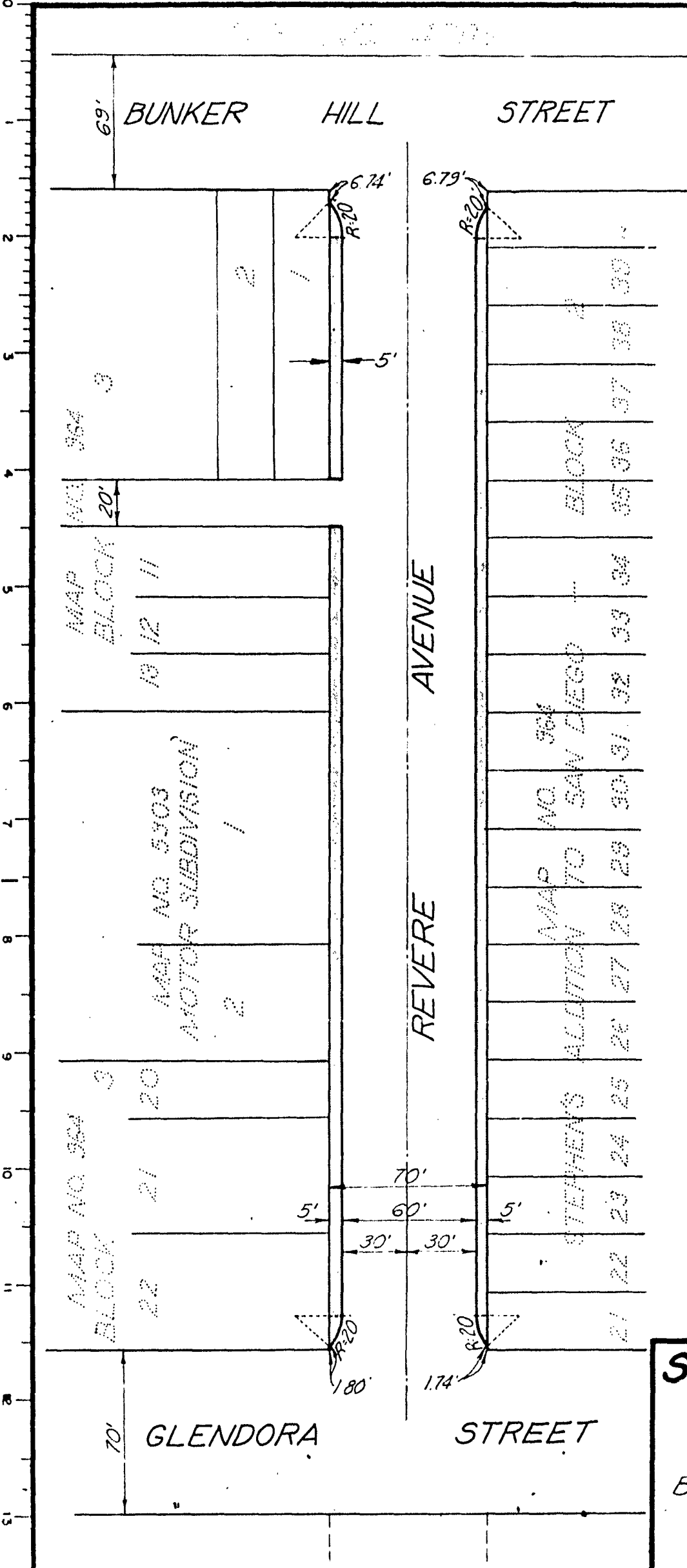
BE IT FURTHER RESOLVED, that portions of REVERE AVENUE
