APPROVING MAP OF OAKS NORTH UNIT NO. 3 SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:


Said Council hereby finds that that certain map surveyed by JOHN F. TANNER, Registered Civil Engineer, and entitled "OAKS NORTH UNIT NO. 3 Being a subdivision of a portion of Rancho San Bernardo, in the City of San Diego, County of San Diego, State of California, according to Map thereof recorded in Book 2, page 462 of Patents, records of said County.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following streets, to wit: Plaza Otonal, Plaza Dolores, Plaza Gitana, Plaza Karena, Plaza Maria, Plaza Marlana, and Paseo Del Verano, for public purposes, and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, those easements listed in paragraphs 1, 2 and 3 of the certificate signed by the Owners for: construction and maintenance of sewer, water and drainage facilities, and open space; as granted and shown on said map and subject to the conditions expressed therein.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and those easements listed in paragraphs 1, 2 and 3 of the certificate signed by the Owners are accepted on behalf of The City of San Diego, a municipal corporation, all as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
