WHEREAS, the United States Border Patrol Detention Facility in San Ysidro was originally constructed in a relatively isolated portion of the San Ysidro community; and

WHEREAS, this facility is presently no longer consistent with the surrounding community; and


WHEREAS, the San Ysidro Community Planning Group and the San Ysidro Elementary School District Board have urged the relocation of the present facility to a more appropriate site; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that said Council urges the federal government to relocate its Border Patrol Detention Facility in San Ysidro to a more appropriate area.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to initiate discussions with the United States federal government to examine the feasibility of said relocation and to offer the assistance of The City of San Diego in this matter.
