

RESOLUTION NO. 208765 SEP 6 1973

BE IT RESOLVED, by the Council of The City of San Diego that the petition for the construction and installation of certain public improvements on, in and adjacent to Camino de la Reina under the provisions of the Improvement Act of 1911, consisting of three counterparts, and filed in the office of the City Clerk as Document No. 744807 is hereby granted and approved.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to cause the preparation of plans, drawings, typical cross-sections, profiles and specifications for the street improvements and related public drainage facilities for the construction of Camino de la Reina from a point 600 feet west of Mission Center Road to Stadium Way; public water and sewer utilities in Mission Center Road; street widening and traffic signals at the intersection of Mission Center Road and Camino de la Reina; and river slope protection improvements in public drainage easements along the south bank of the San Diego River adjacent to Camino de la Reina, in the City of San Diego, all as generally described in said petition, together with estimates of the costs and expenses of such work, and to furnish this Council with a description of the district and a plat showing the exterior boundaries of the district to be included in the assessment for the work and improvements hereinabove mentioned.
