BE IT RESOLVED, by the Council of The City of San Diego, that the public interest and convenience of said City require the vacation of a portion of the street hereinafter mentioned; and in connection therewith require the reservation of a certain easement for water purposes in the area covered by such street.

BE IT FURTHER RESOLVED, that it is the intention of said Council to order the vacation of DEWEY STREET between National Avenue and Logan Avenue, as more particularly shown on Map No. 13075-B, on file in the office of the City Clerk as Document No. 744840.


