

RESOLUTION NO. 208782 SEP 11 1973

WHEREAS, The City of San Diego is the owner of a certain easement for drainage purposes affecting a portion of Lot 6, Genesee Vista, according to Map 6311 filed in the San Diego County Recorder's Office February 27, 1969; and

WHEREAS, the Community Development Department of The City of San Diego has requested that the City quitclaim to the Owner in Fee Simple of Record its interest in and to said easement; and

WHEREAS, grading and construction work has changed the flow of drainage and said easement no longer meets the requirements of the area which it served; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act because it is part of a private project which received its necessary authorization before December 5, 1972; and

WHEREAS, the City desires to negotiate the sale of said easement to the Owner in Fee Simple of Record, under the provisions of Section 22.0902 (e) of the San Diego Municipal Code, which permits the sale of real property belonging to The City of San Diego by negotiation; and

WHEREAS, the sale of such an interest in real property as this may be reasonably accomplished only by negotiation; and

WHEREAS, \$110 has been received as the negotiated sale price; and

WHEREAS, no real estate broker's commission shall be paid; and

WHEREAS, the sale of the aforementioned property right is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That that certain real property right described in that form of quitclaim deed on file in the office of the City Clerk as Document No. 744846, be, and the same is hereby authorized to be sold by negotiation to the OWNER IN FEE SIMPLE OF RECORD.


2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk as Document No. 744846, quitclaiming to the OWNER IN FEE SIMPLE OF RECORD, an easement for drainage purposes affecting a portion of Lot 6, Genesee Vista, according to Map 6311 filed in the San Diego County Recorder's Office February 27, 1969, as more particularly described in said form of quitclaim deed.

3. That no real estate broker's commission shall be paid by City on the herein-described negotiated sale.

4. That the City Clerk of said City is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
