

RESOLUTION No. 208826


Adopted on SEP 18 1973

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of PENASQUITOS, INC., an Illinois corporation, executed in favor of The City of San Diego, bearing date of July 10, 1973, conveying to said City an easement and right of way for street purposes on a portion of Rancho De Los Penasquitos, according to Map thereof accompanying the Patent to said Rancho, recorded in the Office of the County Recorder of said County in Book 2, Page 385 of Patents, together with those certain drain easements, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named BLACK MOUNTAIN ROAD, and the land therein conveyed as Parcel 2 is hereby dedicated as and for a public street and the same is hereby named PASEO MONTALBAN, and the land therein conveyed as Parcels 3 and 4 are hereby dedicated as and for a public street and the same is hereby named CARMEL MOUNTAIN ROAD.

That the City Clerk of said City is hereby authorized and directed to file the foregoing said deed for record in the office of the Recorder of San Diego County.
