

RESOLUTION NO. 208831 SEP 18 1973

WHEREAS, to complement the proposed underground conversion along Mission Boulevard, between Pacific Beach Drive and the north jetty, arrangements have been made with the Coast Guard to provide a new underground service point for their radio beacon station located on the ocean end of the north jetty; and

WHEREAS, this new service point will be located adjacent to the comfort station in the South Mission Bay Park and will eliminate the need for 13 poles spanning approximately 1,800 feet along the north jetty in the vicinity of Mission Boulevard and the park; and


WHEREAS, because of the small size of this job and its priority nature, this work can be done more economically by the use of city forces than by contract; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the use of City forces to relocate a service point and remove excess overhead facilities along the north jetty, Mission Bay, be and the same is hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$2,200 from Capital Outlay Fund 245 for the purpose of providing City forces and materials for the above stated project is hereby authorized and approved.
