RESOLUTION DIRECTING CLERK TO GIVE NOTICE INVITING
SEALED BIDS AND PROPOSALS

WHEREAS, the Council of The City of San Diego adopted its Resolution of Intention, Resolution No. 208841, declaring its intention to order the work and improvement hereinafter referred to; and

WHEREAS, it is desirable to obtain bids and proposals prior to ordering the work and improvement;

3. The Purchasing Agent of the City of San Diego is hereby directed to post, publish and otherwise give notice inviting such bids and proposals substantially in the form of Exhibit "A" attached hereto, and incorporated by reference herein, in the manner as provided

by law.

NOTICE INVITING SEALED BIDS AND PROPOSALS

IN THE MATTER OF THE IMPROVEMENT OF CAMINO DE LA
REINA AND MISSION CENTER ROAD, IN THE CITY OF SAN
DIEGO, STATE OF CALIFORNIA.

(Camino de la Reina Assessment District)

Pursuant to the provisions of the Improvement Act of 1911, the Council of the City of San Diego hereby invites sealed bids and proposals for doing the work and improvement described in those certain plans, specifications, drawings and estimates contained in Document No. 744873 approved by Resolution No. 208840, and in Resolution of Intention No. 208841 and other contract documents duly adopted therefor by the City Council, to which Document and resolutions reference is hereby made for a description of the work and improvement. Said resolutions and plans, specifications, drawings and estimates are hereby referred to for a description of the work and improvement, the grades to which it is to be done, a description of the district to be assessed to pay the costs and expenses thereof, and for all further particulars.

The proceedings for said work and the construction contract shall be under and in accordance with the Improvement Act of 1911.

NOTICE IS FURTHER GIVEN that the Council has ascertained and declared by the adoption of Resolution No. 208705 on August 28, 1973, and on file in the office of the City Clerk,

the prevailing rate and scale for wages in accordance with law to be paid in the construction of the above-entitled improvement. Said rates and scales are by reference incorporated herein and made a part of this notice.

The City Council reserves the right to reject any and all bids and proposals, and to the extent permitted by law, to waive any irregularity in any bid or proposal.

Each bid or proposal shall be accompanied by cash, or a check payable to the order of the City of San Diego certified by a responsible bank, or a cashier's check, for an amount not less than ten per cent (10%) of the aggregate of the proposal, or a bond as required by Section 5240 of the Streets and Highways Code.

The bids and proposals shall be presented to the Purchasing Agent of the City of San Diego at his office in City Operations Building, 1222 First Avenue, in the City of San Diego, on or before 11:00 a.m. on October 3, 1973.

Bids and proposals will be opened by the Purchasing Agent at a public meeting in Conference Room No. 2 on the Second Floor of the said City Operations Building, at the hour of 11:00 a.m. on October 3, 1973, and he shall report the results of the bidding to the City Council at its next regular meeting after the opening.
