

RESOLUTION NO. 208843 SEP 18 1973

WHEREAS, the City Council of The City of San Diego, on September 4, 1973, introduced Ordinance No. 11122 (New Series) and Ordinance No. 11123 (New Series) regarding noise abatement and control (Section 59.5.0101 et seq. of the San Diego Municipal Code and Sections 33.0203 and 33.0702.1 of said Code); and

WHEREAS, the above referenced Noise Abatement and Control Ordinance provides for the establishment of a Noise Control and Abatement Administrator within the City's Environmental Quality Department and the establishment of a fee schedule for the processing of variances and permits; and

WHEREAS, certain funds are necessary to implement the above ordinances and establish a certain fee schedule; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the transfer of funds in the amount of \$25,274 from the City's 100 General Fund Unallocated Reserve to the Environmental Quality Department (Department and Function 38.00) for the implementation of the above referenced Noise Abatement and Control Ordinance for the remainder of fiscal year 1974 be and the same is hereby authorized.

2. That the fee schedule set forth herein is hereby established to cover the cost and expense of processing applications for variances and permits under the Noise Abatement and Control Ordinance. Such fee as set forth herein shall be paid at the time of the submission of the application to the Noise Abatement and Control Administrator. The following fee schedule shall apply:

Submission of an application for a variance  
or permit under the provisions of the Noise  
Abatement and Control Ordinance . . . . . \$35.00

Business license fees established for Commercial Use Sound Trucks under applicable Municipal Code provisions shall remain in effect.

3. That the foregoing provisions shall not be applicable until such time as the above referenced ordinances are fully adopted and have become effective pursuant to the Charter of The City of San Diego.
