

RESOLUTION NO. 208846 SEP 18 1973

APPROVING MAP OF PACIFIC SORRENTO INDUSTRIAL
PARK SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by O. B. SHOLDERS, a Registered Civil Engineer, entitled "PACIFIC SORRENTO INDUSTRIAL PARK Being a subdivision of portions of Lots 4, 5, and 6 and all of Lots 7, 8, and 9 in Block 6; portions of Lots 1 through 6 inclusive and all of Lots 7 through 12 inclusive in Block 7; portions of Lots 1 through 6 inclusive and all of Lots 7 through 12 inclusive in Block 8, portions of Acre Lots 26 and 27; portions of Kochia Street, Jasmine Street, Iris Street, Roselle Street (formerly Smilax Street) (All formerly unnamed streets) closed and vacated to public use, all in Sorrento Lands and Townsite according to Map thereof No. 483 filed in the office of the County Recorder of San Diego County February 19, 1888, together with a portion of each of Roselle Street, Dunhill Street and Flintkote Avenue as dedicated to public use, all in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public street and portions of public streets, as follows: Roselle Street and a portion of Estuary Way, a portion of Dunhill Street and a portion

of Flintkote Avenue, for public purposes, and said street and portions of streets are hereby declared to be a public street and portions of public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements, with the right of ingress and egress, for the construction and maintenance of sewer and drainage facilities, together with the easement for slope rights, all as granted and shown on said map and subject to the conditions expressed therein.

BE IT FURTHER RESOLVED, that said Council hereby rejects as a dedication for public street that portion of Lot 5, marked "Reserved for Future Street" as shown on this map, under the provisions of Section 11616 of the Business and Professions Code.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street and portions of public street are accepted on behalf of the public as heretofore stated; and that those certain easements, with the right of ingress and egress, for the construction and maintenance of sewer and drainage facilities, together with the easement for slope rights, are accepted on behalf of The City of San Diego as above stated; and said Council has rejected that portion of Lot 5, marked "Reserved for Future Street" shown on this map within this subdivision, all as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
