VACATION OF WING STREET ADJACENT TO LOTS 12 AND 17,
POINT LOMA PARK SOUTHWESTERLY OF THE NORTHWESTERLY
PROLONGATION OF THE SOUTHERLY LINE OF THE NORTHERLY
112.30 FEET OF LOT 17, POINT LOMA PARK.

BE IT RESOLVED, by the Council of The City of San Diego,
California, that WING STREET adjacent to Lots 12 and 17, Point
Loma Park southwesterly of the northwesterly prolongation of the
southerly line of the northerly 112.30 feet of Lot 17, Point Loma
Park, as more particularly referred to in Resolution of Intention
No. 208633 is unnecessary for present or prospective
public street purposes.

BE IT FURTHER RESOLVED, that the public interest, convenience
and necessity of said City requires the reservation of a certain
public easement, as more particularly referred to in Resolution of
Intention No. 208633.

BE IT FURTHER RESOLVED, that WING STREET adjacent to Lots 12
and 17, Point Loma Park southwesterly of the northwesterly pro-
longation of the southerly line of the northerly 112.30 feet of
Lot 17, Point Loma Park, as more particularly shown on Map No. 13102-B
on file in the office of the City Clerk as Document No. 744621.
which said map is attached hereto and made a part hereof, be, and
the same is hereby vacated.

BE IT FURTHER RESOLVED, that The City of San Diego reserves
and excepts from the foregoing vacation the permanent easement
as more particularly described hereinafter:

Reserving and excepting to The City of San Diego the right, easement and privilege of placing, constructing, repairing, replacing, maintaining, using and operating public utilities of any kind or nature, including, but not limited to sewer, water and drainage facilities and all necessary and proper fixtures and equipment for use in connection therewith, through, over, under, upon, along and across the hereinafter described easement, together with the right to maintain the said easement free and clear of any excavation or fills, the erection or construction of any building or other structures, the planting of any tree or trees thereon, or the drilling or digging of any well or wells thereon, together with the right to otherwise protect from all hazards the operation and use of any right hereby reserved. Upon written permission of the City of the right to utilize the said easement herein, the owners of the underlying fee may utilize the above described parcel of land for structures, the planting or growing of trees or the installation of privately owned pipelines.

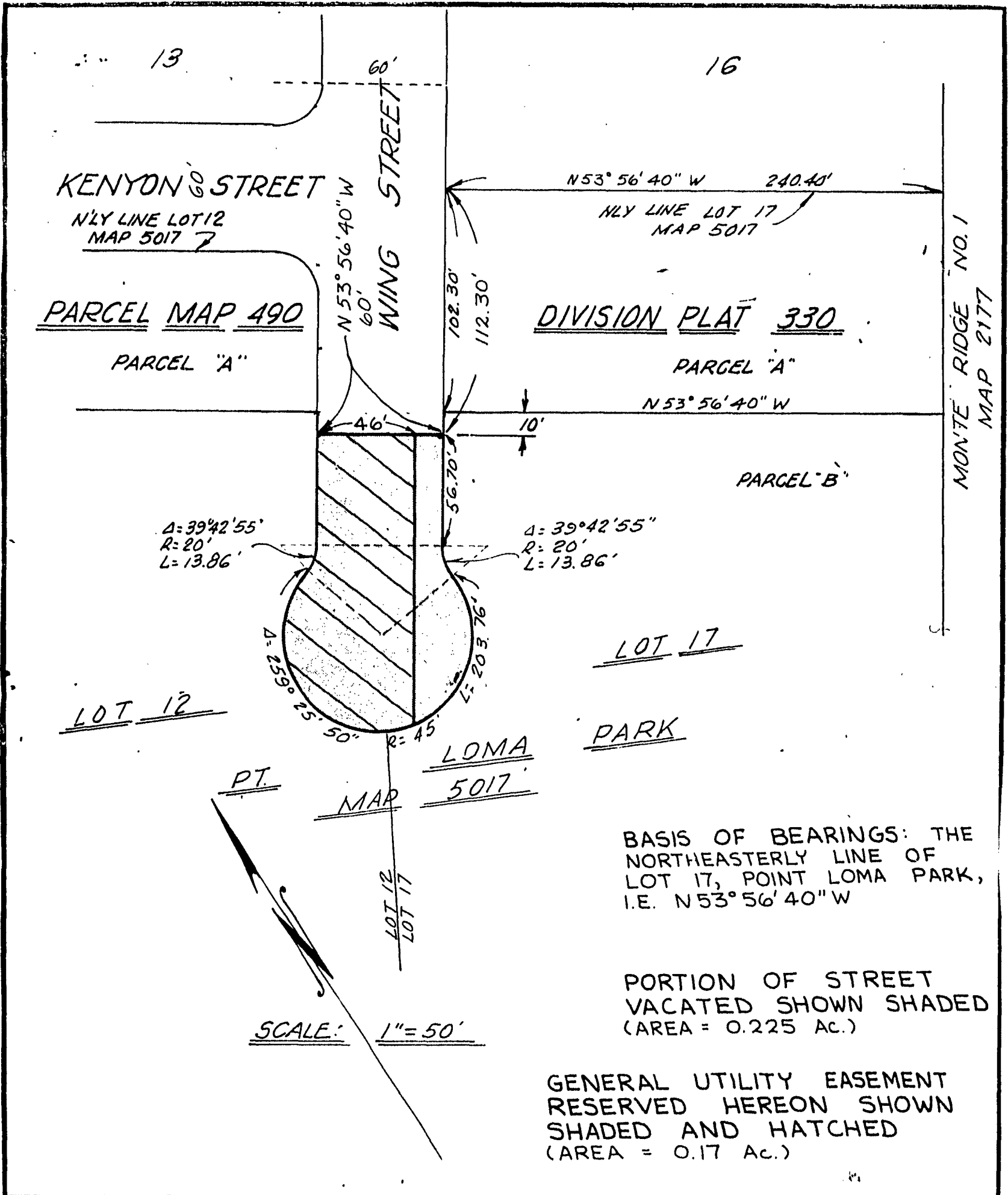
