That the City Manager be and he is hereby fully authorized and empowered to execute, for and on behalf of said City, an agreement with the MEXICAN CIVIC ASSOCIATION OF SAN YSIDRO to produce and conduct a celebration of Mexican Independence to be held in San Ysidro on September 14, 15 and 16, 1973, under the terms and conditions set forth in the form of agreement on file in the Office of the City Clerk as Document No. 744935.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer within the 224 Fund the sum of \$3,200 from Contingency Reserve Account (52.99) to Mexican Independence Celebration Account (52.64), to be used solely and exclusively for expenses incurred in this celebration.
