

RESOLUTION NO. 208871 SEP 20 1973

WHEREAS, the noise in San Diego has risen at a rate deemed to be detrimental to the health and welfare of the citizens of this City; and

WHEREAS, The City of San Diego has adopted a comprehensive noise abatement and control ordinance on September 18, 1973, in an attempt to stop the ever increasing noise pollution problem in this City; and

WHEREAS, one of the most significant single sources of noise pollution is aircraft; and

WHEREAS, historically San Diego has been aviation oriented, is the home of North Island and Miramar Naval Air Station, a major commercial airport, and two City-owned municipal airports, all of which conduct extensive and increasing air operations; and

WHEREAS, the present major commercial airport, San Diego International Airport--Lindbergh Field, has, since it was opened in August 1928, experienced commercial and general aviation growth rates which exceed the per capita growth rate; and

WHEREAS, the change-over from propeller to jet aircraft engine operation has increased aircraft noise to an almost intolerable level to those persons in the immediate vicinity of airports; and

WHEREAS, recent studies have shown that over 115,000 people living in approximately 13,250 housing units adjacent to

Lindbergh Field are seriously affected by extremely high noise levels which are increasing each month as additional flights are added to existing flight schedules; NOW, THEREFORE, BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Council of The City of San Diego urges the United States Senate Committee on Public Works and Commerce to adopt effective noise emission standards which will reduce present aircraft and airport noise levels in and around urban areas.
