BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the Offer to Dedicate of SAN DIEGO LIQUID GAS AND APPLIANCE, INC., a California corporation, executed in favor of The City of San Diego, bearing date of July 23, 1973, granting to said City a twenty-one year option to dedicate to public use for street purposes certain property described as all that portion of Lot 2 of Dowdy's Subdivision Unit No. 2, according to Map thereof No. 6828, filed in the San Diego County Recorder's Office on January 28, 1971, as more particularly described in said instrument, be, and the same is hereby accepted on the conditions therein expressed.

BE IT FURTHER RESOLVED, that by this acceptance the City does not dedicate to public use for street purposes the portion of land described in said instrument but reserves the right to so dedicate at a future time.

BE IT FURTHER RESOLVED, that the City Clerk of said City is hereby authorized and directed to file the foregoing said offer to dedicate in the office of the Recorder of San Diego County.
